### Roofs



## **Chimney Repair**

The contractor, Structural Preservation System, will be returning the week of April 28<sup>th</sup>. The work will be 7 chimneys in Friendship Lane and 13 chimneys in Grove Lane.

In addition, the ten new caps will be installed in landing Lane. This work will take approximately 90 days to complete.

# Fireplace Cleaning

Each year you should have your chimney flue inspected and cleaned, if you use your fireplace. The work on the exterior chimneys does not include the inspection of your flue.

# **Bird Feeders**

Although they are meant for birds, they attract rodents, raccoons, skunks and coyotes. Please do not put out a bird feeder.
